Style Guide and Information for Authors

I. Text:

1. Title:

For the coordination of the style, the chapters and sections must be numbered by the following manners:

For manuscripts in Chinese: “壹、一、(一)、1、(1)、①、甲、(甲)”。

Title 「壹、」 in 「標楷體 18 級」; Title 「一、」 in 「標楷體 14 級」。

For manuscripts in English: “ I . A. (A) 1. (1) a. (a)”。

2. Paragraphs:

From the start of each paragraph, there shall be space of two words, and manuscripts must be typewritten in Word 7.0, A4, in 「新細明體 12 級」, single-spaced. Also, manuscripts must be arranged by the following order: Chinese and English abstracts, Chinese and English keywords, table of contents, text.

3. Author's name and position:

Author's name shall be typed beneath the title of the article; the academic background and the position shall be presented in notes.

II. Notes:

1. Detailed references shall be included in all notes; a note quoted from a secondary source shall be specified. Century style (A. D.) shall be used for specifying a year.
2. Notes shall be on the same page with the text, i.e. footnote. When citing to the immediately preceding note, use “*id.* at ○(page)” ; When citing to a not immediately preceding note, type the author's name and use “*supra* note ○, at ○(page)”。
3. Materials referred shall be specified the sequence of the edition, except for the first edition. The constitutional interpretation by grand justices, laws, and administrative orders, are free of giving dates or reference.
4. The typeface of notes is 「新細明體 9 級」, the space is 12pt. The examples of notes are as follows:

III. Referred Materials:

1. For the convenience of readers, contributors are requested to present all materials quoted in the text and notes on the final page of manuscripts.
2. No series numbers. Chinese and Japanese materials shall be at the top, then other foreign materials follow; all arranged alphabetically by author's name. Several materials by a single author shall be arranged by years.
3. The format of arranging materials shall be the same with the format of arranging notes, and the page number is not required for Chinese and Japanese materials. Other foreign materials shall cite the beginning and ending pages.
4. The years are presented in century style (A.D.). Authors' name, titles of volumes and articles, and publication details are separated by commas.
